FORMATION MINUTE

As this pandemic drags on, it seems as if the world has been turned upside down. Rules and regulations seemed to change by the hour in the first few weeks, but now things seem to have settled down into somewhat of a routine. While the conditions of today are not ideal, at least there is a little bit of regularity, and we can begin to adjust. None of this has been easy, and we will all be grateful when we can get back to the way things were before this began (or as close to that as possible). With all of this uncertainty, there are two saints whom the Church celebrates this month that I'd suggest we, as ministries of the Catholic Church, might turn to for help: St. Joseph and the Blessed Virgin Mary.

In the Church's calendar, there are many feast days. One of the greater feast days is the Solemnity of St. Joseph, which we celebrate on March 19th. In 1955, Pope Pius XII added a second feast of St. Joseph to the calendar. In order to combat the atheistic, communist "May Day" celebrations which were becoming more popular around the world, the pope established May 1st as the Feast of St. Joseph the Worker.

The Solemnity of St. Joseph focuses primarily on St. Joseph's role in the Holy Family as the husband of Mary and foster-father of Jesus. The feast of St. Joseph the Worker, on the other hand, focuses our attention on how God chose a poor, humble carpenter for that role, and how he can serve as a model of virtue for workers of all sorts. So whether you're overworked and exhausted or furloughed or anywhere in between, we can all turn to St. Joseph to intercede for us.

While St. Joseph has two feast days on the calendar, the Blessed Virgin Mary, his wife, has a number of different celebrations in her honor. In fact, along with all of her feast days, the Church has set aside the entire month of May as a special time to honor our Blessed Mother. During this month, churches, families, and individuals will often dedicate themselves to Mary in a special way, adding special devotional practices, including praying the rosary, doing a May crowning.

One special dedication is taking place this year by the bishops in the United States and Canada. On May 1st, the bishops are re-dedicating our countries to Mary under her title "Mother of the Church". During this time of pandemic, the bishops thought it good to ask in a special way for Mary's maternal guidance and protection.

Therefore, perhaps we might join the bishops and dedicate ourselves to Mary, asking her to watch over us as we carry out the work of her son, Jesus, as well as say a prayer to St. Joseph asking him to intercede for us and to prosper the work we do.

St. Joseph the Worker, and Mary, Mother of the Church, pray for us!



Ethical and Religious Directives for Catholic Health Care Services

Part One—The Social Responsibility of Catholic Healthcare Services.

- 5. Catholic health care services must adopt these Directives as policy, require adherence to them as a condition for medical privileges and employment and provide appropriate instruction regarding the Directives for all involved in our ministry.
- 6. A Catholic health care organization should be a responsible steward of the health care resources available to it. Collaboration with other health care providers in ways that do not compromise Catholic teaching is an effective means of such stewardship.
- 7. A Catholic health care institution must treat its employees respectfully and justly. Equal employment opportunities for anyone qualified for the task regardless of a person's race, sex, age, national origin or disability; a work environment that promotes employee participation; ensures employee safety and well-being; just compensation and benefits.
- 8. Catholic health care institutions have a unique relationship to both the Church and the wider community. Relevant requirements of canon law will be observed with regard to the foundation of a new Catholic health care institution; the substantial revision of the mission of an institution; and the sale, sponsorship transfer or closure of an existing institution.
- 9. Employees of a Catholic health care institution must respect and uphold the religious mission of the institution and adhere to these Directives. They should maintain professional standards and promote the institution's commitment to human dignity and the common good.

At St. Aloisius Medical Center we are prepared for whatever comes our way. Our Emergency Department has supplies and personal protective equipment needed to care for anyone. We have staff trained in caring for COVID-19 patients.

Our Medical Surgical floor has a designated isolation wing should this become necessary to care for COVID-19 patients.

Our Long Term Care has a designated isolation wing almost ready to care for any residents who test positive and do not need hospitalization.

We screen everyone coming into our ministry and everyone will be masked to prevent any contamination. Vendors and dropping their deliveries outside and our staff are bringing them in the building.

Department managers and other partners in this fight meet Monday, Wednesday and Friday at 8:00 am to discuss any concerns. We begin these meetings with the Mission Statement and prayer. As the situation changes, plans are adjusted to fit the needs.

May 1 businesses were allowed to start opening up using proper precautions such a distancing, hand sanitizing, glove usage. St. Aloisius Clinic is seeing more patients, mammograms are being scheduled; therapies department is seeing more patients—all while keeping patients distanced from others. Appointments are staggered; waiting rooms have less seating. Family members and other people are discouraged from coming with the patient unless necessary.
